U.S. Navy is returning to Subic Bay

Herb Dorsey recently sent out an email that detailed the US Navy's return to Subic Bay. Most of us who served on the Cal remember Subic Bay as our "home away from home" during our Westpac cruises.

Subic has been an important deepwater port in the Philippines since 1885 when the Spanish built the first navy base there. It came into American hands after the Spanish-American War and has been a U.S. Navy base since then, with the exception of the Japanese occupation between 1941 and 1945. Many of us became acquainted with Subic and Olongapo in the post World War II era through our cruises on the Cal during the Cold War and the Vietnam War.

After the devastating eruption of the Mount Pinatabo volcano in 1991, Clark Air Force Base was destroyed. Subic and Cubi Point Naval Air Station were repaired and reopened, but shortly thereafter, the United States turned both over to the Philippine government and withdrew all its ships and materiel from the base.

I became aware of a renaissance of the base as a U.S. port of call due to my friendship with a colleague with whom I worked in my career as a high school administrator here in Maine. He is presently the headmaster of Lee Academy, a private high school in northern Maine which is affiliated with Daegu International School, a Korean high school which has a campus on Cubi Point called the American International School of Subic. The school is situated on the hill that overlooks the old air

station and the bay. The purpose of these schools is to funnel tuition-paying Asian students to northern Maine to offset our declining school-age population.

It was through my former colleague that I learned of the return of the U.S. Navy to Subic. He has made many trips to the school at Cubi Point, and knowing of my Navy background, he has given me pictures and kept me abreast of the changes in the area.

As a counter to the growing belligerence of the Chinese in the seas between China and the Philippines, the Philippine government has asked the U.S. Navy to again use Subic as a base of operations in the western Pacific. After the Navy left in 1992, the Philippine government had developed Subic into a free-trade port using the facilities the United States left behind, so much of the infrastructure for the docking and maintenance of the ships remained in place. The difference this time is that the infrastructure is now the property and under the control of the Philippine government and the U.S. Navy is there as a guest.

We all have various memories of our times in Subic. I would encourage shipmates who are curious to Google Subic Bay on your computers and read about its history. In addition, you can use Google Maps to get a bird's eye view of the bay, the old bases on both sides and Olongapo City. One can even see that the old fuel piers where we spent many an hour loading fuel are still in use for that purpose.

David Joseph Babulski of Sneville, GA, died 11 April 2016. Born 23 Sept. 1944 in San Bernardino, CA, David served on the Caliente from 1965 to 1967 as RD3. Instead he ended up in private industry as a professional educator, obtaining both a masters and a doctorate in Earth Science. 
