#### By-Laws of the U.S.S. Caliente Association (Original)

#### ARTICLE 1: NAME

Section A: The name of the organization shall be: The U.S.S. Caliente Association.

#### ARTICLE II: PURPOSE

Section A: The purpose of the U.S.S. Caliente Association is to assist former shipmates, who served aboard the U.S.S. Caliente (AO-53) to meet and communicate with each other and to preserve the accurate history of the ship.

#### ARTICLE III: MEETINGS

Section A: A business meeting of the U.S.S. Caliente Association will be held on the date and in the city designated and voted on by the members present and voting at the business meeting of the previous reunion.

#### ARTICLE IV: OFFICERS

- Section A: Officers of the Association shall consist of a President, Vice President, Secretary/Editor, Treasurer and Chaplain. No Officer shall receive any compensation or other benefit of material value.
- Section B: The officers will be elected at each reunion business meeting by the members present and voting.
- Section C: The duties of the President shall be to preside at the reunion business meeting, protect the general welfare of the Association and render assistance to the Association officers as required. The President working with and through the Treasurer shall account for all monies and pay all bills associated with the reunion. Excess monies from the reunion will be turned over to the Association Treasurer. The President and Treasurer will submit a reunion financial report to the Secretary/Editor for inclusion in the first newsletter after the reunion.
- Section D: The duties of the Vice President are to assist the President and to assume all duties of the ` President in the absence of that officer. He will render assistance to the other Association Officers as is necessary.
- Section E: The duties of the Secretary/Editor shall be to record the proceedings of the business meeting; respond to or refer any correspondence to the proper officer; gather and prepare material for, publish and mail to each member a newsletter periodically.
- Section F: The duties of the Treasurer shall be to receive all monies of the Association; maintain any bank accounts that may be opened by the Association; pay all authorized bills; report quarterly to the President and provide a financial statement at the regular business meeting, recapping all receipts and expenditures of the Association.
- Section G: The duties of the Chaplain shall be to provide the opening invocation; prayer for the departed shipmates and the closing benediction.

#### ARTICLE V: MEMBERSHIP

- Section A: Membership is the U.S.S. Caliente Association shall be primarily, but not limited to, those persons who served aboard the U.S.S. Caliente (AO-53) while the ship was in commission and their spouse and relatives.
- Section B: Active membership consists of those persons who are currently paid-up on their yearly dues.

- Section C: Honorary memberships may be granted by the Association to those persons who have directly or indirectly contributed their time, talent or assistance to the Association and to the widows of former shipmates. Honorary membership may be granted by being recommended by an active member in good standing and upon a simple majority vote of the members present and voting at a regular business meeting of the Association. No yearly dues payment is required for Honorary members.
- Section D: Life membership shall be granted to any Association member who pays a one-time fee of one-hundred fifty dollars (\$150.00) or if over eighty (80) years old on the dues date, the sum is fifty dollars (\$50.00). Life membership may be granted to other persons by a majority vote of members present at a regular scheduled business meeting of the Association.
- Section E: Active members who have failed to pay their dues by January 1<sup>st</sup> of any calendar year, will be notified and will be placed on the inactive membership roster. Inactive members may be reinstated to the active list by paying the current year dues. If the member is not reinstated after two (2) years on the inactive membership roster, he will be removed from roster.

#### ARTICLE VI: DUES

- Section A: The annual dues amount will be determined at the regularly scheduled business meeting. A majority vote of the members present will determine what the dues will be for the coming year.
- Section B: No dues are required of a life member.
- Section C: No dues are required from Honorary Members.

#### ARTICLE VII: AMENDMENTS

Section A: Amendments to these by-laws shall be made by majority vote at the regular business meeting.

#### ARTICLE VIII: FINIS

Section A: When the time should come when the members of the U.S.S. Caliente Association decide that to continue to exist as an organization is no longer practical, the following rules shall apply:

The decision to disband can be decided at a regular business meeting by a vote of the majority of the members present.

All monies and property belonging to the U.S.S. Caliente Association, in the event of a decision to disband, will be donated to the Navy Memorial in Washington D.C. as determined by the voting members. Monies shall be donated only after all outstanding bills have been paid in full.

A notice of action taken, shall be sent to all surviving members whose current address is on file.

The following changes to the U.S.S. Caliente Association By-Laws are recommended by President **Bob Howard**, Treasurer **Pat Hurton** and **John Creedon** 

The Association has been successfully operating over the past seven years but the By-Laws have not kept up with of how the Association has operating. As a result the minor changes detailed below can be summarized as minor changes that merely reflect the past seven years of operation.

Recommending the elimination of the Chaplain's position as an officer reflects the fact that his position is meant to augment the Association activities and is not meant to be instrumental in its operation. It does not diminish the services our Chaplains have performed for us.

The deletion of Pipeline editor from the secretary's duties reflects the difficulty we have had in getting one person to sign up for both responsibilities. This year we have had a person come forward and be willing to fulfill the duties as Pipeline editor and another person willing to be Secretary. Separating the two duties will increase the number of persons involved in the Association's operations. Something we have been striving for.

The following are full details of the changes and a full copy of the revised By-Laws

Article 1: NAME: - Added "hereinafter know as the Association" after U.S.S. Caliente Association.

Reason: Helps shorten the reference in future paragraphs.

Article II: PURPOSE - Changed "the accurate history" to "to enhance the history of the ship through the preservation of stories provided by members"

Reason: The history of the ship is maintained by the naval archives. The Association should gather and preserve stories from Association members.

Article III: MEETINGS -

- a) Changed Section A to refer to the business meeting as part of the reunion.
- b) Added the business meeting at which the next reunion is set
- c) Added how officers are elected
- d) Establishes rules for meetings and the conduct of business

Reason: To reflect how the Association has been operating

#### Article IV: OFFICERS -

Section A:

The Chaplain has been deleted as an officer and has been made an appointed position
 New last sentence.

Reason: To reflect how the Association has been operating

#### Section B:

Removed reference to how officers are elected.

Reason: Article VI on Voting details the "how" officers are elected

#### Section C:

No substance changes. Slight wording changes.

Reason: To reflect how the Association has been operating

Section D: No change

Section E:

Deleted - "the editor of the Pipeline" as a responsibility.

Reason: To allow for the inclusion of additional people who assist the organization and distributer the workload

#### Section F:

Added sentence regarding signature authority.

Reason: As of now the treasurer is the only one on the bank account. Although we don't need two signatures we do need two persons who can access the account in the event of the incapacitation of the Treasurer

#### Section G:

Deleted the chaplains duties

Reason: we are recommending he no longer be an officer

#### New Section G

Added a paragraph regarding appointed positions

Reason: Allows for the appointment of persons who wish to assist in the operation of the Association to be appointed by the President

#### New Section H:

Covers replacement of an officer.

Reason: Allows for the other officers to ask for the resignation of an officer who cannot perform or is neglect in his duties.

#### Article V MEMBERSHIP -

Article VIII: EXPENDITURES - New. Needed to cover various situations regarding payment of obligations

Article IX AMENDMENTS - Slight wording change.

Article X: FINIS - Slight wording changes.

#### ARTICLE 1: NAME

Section A: The name of the organization shall be: The U.S.S. Caliente Association\_ (hereinafter known as the Association).

#### ARTICLE II: PURPOSE

Section A: The purpose of the Association is to assist shipmates, who served aboard the U.S.S. Caliente (AO-53), to meet and communicate with each other and to enhance the history of the ship through stories provided by members.

#### ARTICLE III: MEETINGS

- Section A: Periodic reunions of the members shall be held. The goal is to hold a reunion approximately every twelve to eighteen months.
- Section B: As part of each reunion, a business meeting shall be held. At the business meeting the location, and approximate date, of the next reunion shall be determined.
- Section C: As part of each business meeting officers shall be elected.
- Section D: Robert's Rules of Order shall define any items not delineated herein regarding meetings and voting.

#### ARTICLE IV: OFFICERS

- Section A: Officers of the Association shall consist of a President, Vice President, Secretary and Treasurer. No Officer shall receive any compensation or other benefit of material value. The Association officers are the only persons who can conduct business in the name of the Association.
- Section B: The officers shall be elected at each reunion business meeting.
- Section C: The duties of the President shall be to preside at the reunion business meeting, protect the general welfare of the Association and render assistance to the Association officers as required. The President will co-ordinate the arrangements for the reunion for which he is elected. The President, working with and through the Treasurer, shall account for all monies and pay all bills associated with the reunion. Excess monies from a reunion will be turned over to the Association Treasurer. The President shall ensure that a final reunion report is included in the first Pipeline that is distributed following the reunion.
- Section D: The duties of the Vice President are to assist the President and to assume all duties of the President in the absence of that officer. He will render assistance to the other Association Officers as necessary.
- Section E: The duties of the Secretary shall be to record the proceedings of the business meeting; respond to or refer any correspondence to the proper officer; assist in the gathering of materials for a periodic newsletter called the "Pipeline".
- Section F: The duties of the Treasurer shall be to receive all monies of the Association; maintain any bank accounts that may be opened by the Association and provide a financial statement at the regular business meeting, recapping all receipts and expenditures of the Association. The Treasurer shall ensure that the President is an authorized signature on any Association bank account.

- Section G: The President, with the concurrence of the majority of the other officers, shall be able to appoint positions that will assist in the running of the Association. Such positions can include, but not be limited to; a Pipeline editor, a membership chairman, a webmaster, historian and chaplain.
- Section H: The Association officers may ask for the resignation of any officer who is neglect in, or cannot perform, his duties. If the officer resigns the other officers can appoint a temporary replacement. The position will come up for vote at the next business meeting of the Association.

#### ARTICLE V: MEMBERSHIP

- Section A: Membership in the Association shall be primarily, but not limited to, those persons who served aboard the U.S.S. Caliente (AO-53) while the ship was in commission. Spouses and relatives may be granted membership as appropriate.
- Section B: Active members consist of those persons who are current in their yearly dues payment.
- Section C: Honorary memberships may be granted to those persons who have directly or indirectly contributed their time, talent or assistance to the Association and to the widows of former shipmates. Honorary membership may be granted through a recommendation of any active Association member. All persons recommended for honorary membership shall be presented to the Association at a reunion business meeting. A majority vote of the active members present and voting at that business meeting shall be necessary for honorary membership. Honorary members shall not be required to pay annual dues.
- Section D: Life membership shall be granted to any Association member who pays a one-time fee of one-hundred fifty dollars (\$150.00) or if over eighty (80) years old on January 1<sup>st</sup> of the current year the sum is fifty dollars (\$50.00). Life membership may be granted to other persons by a majority vote of the active members present and voting at any business meeting of the Association.
- Section E: Active members who have failed to pay their dues by January 1<sup>st</sup> of any calendar year will be notified and placed on the inactive membership roster. Inactive members may be reinstated to the active list by paying the current year dues. If the member is not reinstated after two (2) years on the inactive membership roster, he will be removed from roster.

#### ARTICLE VI: VOTING

- Section A: Only active members shall participate in voting
- Section B: Voting for Officers; a majority vote must be obtained to elect any candidate to office. If a majority is not obtained, and there is more than one candidate, there will be a runoff vote between the two candidates receiving the highest number of votes.
- Section C: Voting on other actions (except Amendments see Article VIII);

If there is more than one item being voted on, the item receiving a plurality (the most number of votes) shall be deemed the winner. If there is only one item being voted on a majority vote, of the active members voting, is necessary to carry the item.

#### ARTICLE VII: DUES

- Section A: The amount of annual dues shall be determined at the business meeting. A majority vote, of the active members voting, shall determine the dues amount for the coming year.
- Section B: No dues are required from life members.

Section C: No dues are required from Honorary Members.

#### ARTICLE VIII: EXPENDITURES

- Section A: The Treasurer and/or the President are responsible for payment of any debts of the Association. Normal debts include, but are not necessarily limited to;
  - 1) Bills associated with production and distribution of the "Pipeline",
  - 2) Bills associated with mailings to members regarding dues i.e.,
    - a) renewal confirmation
    - b) new memberships confirmation
    - c) past due notices to members who have failed to pay their dues.
  - 3) Bills associated with recruiting,
  - 4) Bills associated with reunions but not covered through member payments for the reunion,

5) Bills associated with the purchase of U.S.S. Caliente shoulder patches and ship's patches or other memorabilia as appropriate.

- Section B: The Treasurer and the President, in concurrence, shall be authorized to make other expenditures of up to two hundred dollars (\$200.00). Any such expenditure must be specifically presented to the members present at the next reunion business meeting.
- Section C: Incurrence of any other liability shall have the concurrence of the President, Vice President and Treasurer prior to the liability being incurred. Given such concurrence, the liability may be incurred and payment then made. Any such expenditure must be specifically presented to the members present at the next reunion business meeting.
- Section D: U.S.S. Caliente memorabilia shall only be purchased with the concurrence of all the Officers of the Association. The sale of memorabilia shall be through the President or the Treasurer, with the goal of not making or losing money. If the sale results in profit the funds shall be placed in the Association bank account.

#### ARTICLE IX: AMENDMENTS

Section A: Amendments to these by-laws shall be made by a majority vote of active members voting at any business meeting.

#### ARTICLE X: FINIS

- Section A: When the time should come that the members of the Association decide that to continue to exist as an Association is no longer practical, the following rules shall apply:
  - 1. The decision to disband can be decided at a regular business meeting by a majority vote of the active members present and voting at that meeting. In the event it is not practical or desirable to have a regular business meeting all active members shall be notified of the intention to disband and shall be polled with regard to their individual desire. The majority vote, of those choosing to vote, shall prevail.
  - 2. Any outstanding financial obligations of the Association shall be identified and paid.
  - 3. All remaining monies and property, belonging to the Association shall be donated to the U. S. Navy Memorial in Washington D.C.
  - 4. A notice of action taken shall be sent to Association members who have current regular or email address on file.
